I / We authorize the credit card listed above to be used as a damage/security deposit for each Polaris RZR/RANGER I/ we rent. I/ We are fully responsible for this Polaris RZR/RANGER and will pay for all broken, cracked, bent, ripped and missing pieces of my/ our Polaris RZR/RANGER if damaged while in my/ our possession. I/ We will inspect the Polaris RZR/RANGER prior to riding them and note any previous damages on the check our form during the pre-ride inspection. I am/ We are agreeing to pay for all damages today.

I/ We understand that there are two different accident coverage options on my Polaris RZR/RANGER rental. Either: Premier coverage with a \$1500 deductible or standard coverage with a \$3000 deductible. I/ We understand that if I/We damage the Polaris RZR/RANGER I/ We will be paying for the total cost of the damage if the deductible is not met. I/ We will pay the full deductible if the damage is greater than the coverage I/We selected.

I/ We understand that if the Polaris RZR/RANGER is rolled over while in my possession the damage will no matter what meet our deductible and I/ We will pay the deductible whatever it may be \$1500 or \$3000.

I/ We understand that there is ½ hour minimum labor charged to all damages. Labor rate is \$120 per hour. Labor rate is calculated using the Manufacturers Flat Rate Manual and multiplying by 1.3 I/ We agree to pay the manufacture suggested retail price for parts.

If I/ we need to be rescued or towed (for non-mechanical reasons) here will be a minimum \$100 rescue fee. This fee includes the 1st hour of rescue. Each additional hour will be billed at \$100 per hour. An average rescue is \$300 to \$400.

I/ We understand that there will be a minimum 3 days "Loss of Rent" (not to exceed 14 days) charge for all major damages to the Polaris RZR/RANGER caused by rollovers and collisions. Loss of Rent Rates are visibly posted. Average loss of rent is \$1300- \$1700.

I/ We understand that excessive mud and water may cause the Polaris RZR/RANGER to overheat and in some cases engine failure. I/ We agree to pay a minimum \$100 as a cleaning fee for excessively muddy machines. In the event that my Polaris RZR/RANGER is non-operable because of excessive mud and water I/ we agree to forfeit the remainder of my/ our rental and pay appropriate costs related to repairs, rescue, and loss of rent.

Included with each rental is a helmet. If I/we damage, lose, or blood contaminate the helmet(s), I/ we authorize \$75 to be charged to my credit card listed above.

I/ We agree to ride sober. On The Trail Rentals has a ZERO tolerance policy for alcohol and drugs. If On The Trail Rentals suspects use of alcohol or drugs at any point in the rental process, you will forfeit your rental and the entire amount of the rental costs.

I/ We understand that On The Trail Rentals does NOT refund money for early returns on rentals.

I/ We understand that there are additional charges if we do not return the Polaris RZR/RANGER back on time. Rental return times will be noted on ipad check out. It is my/ our responsibility to know what time I am/ we are due to return. On The Trail Rentals bills \$20 for every 10 minutes late.

I/ We understand that there is no way for On The Trail Rentals to predict the weather or control trail conditions.

I/ We understand that I am/ we are responsible for damages resulting from striking hazards along the trail such as rocks, stumps, trees, etc.
